

Expectation

Young, smart, high-tech company should have low vulnerability to phishing

Result

1 out of 4 users were successfully phished - including **TWO** security engineers involved in the study!

Just like the decision to avoid the dark alley and choose the well-lit street at night, your behavior affects your vulnerability...










Example: Phishing Email

Phishing attack simulations highlight the human vulnerabilities within the organization







Don't Get Blindsided!

You clicked on a link you shouldn't have

You can Relax...

This was a sanctioned Phishing test performed on behalf of your company to test cyber security awareness.

Malicious actors will not be so forgiving if you click one of their links. Remember to always think twice before clicking and ensure the email was sent from the correct address.

Example: Phishing Click Landing Page

Behavior change starts with the shock of an unexpected outcome (i.e. landing page to the left).



Protect the Human Element
